RESOLUTION APPOINTING COMMITTEE MEMBERS

WHEREAS the Governance Manual of the RPBCWD states that members on standing committees shall be decided annually at the January meeting; and

NOW THEREFORE BE IT RESOLVED that the Board of Managers of the Riley-Purgatory-Bluff Creek Watershed District hereby appoints the following managers as committee members to serve on the Governance Committee, Personnel Committee, and Audit and Finance Committee.

GOVERNANCE COMMITTEE MEMBERS

i. Governance Committee. The Governance Committee is a standing committee of the Board of Managers and shall consist of two managers, with support from the administrator and the District's legal counsel. The committee shall review annually the Governance Manual, and make recommendations for revisions to the Board of Managers. All meetings of the committee shall be noticed and open to the public as required by the Open Meeting Law.

Manager Koch moved to nominate Manager Koch for the Governance Committee.

ii. Personnel Committee. The Personnel Committee is a standing committee of the Board of Managers and shall consist of two managers, with support from the administrator and the District’s legal counsel. The committee shall make recommendations to the Board of Managers on personnel and human resources matters. All meetings of the committee shall be noticed and open to the public as required by the Open Meeting Law, except for meetings which are required to be closed or may be closed pursuant to the Open Meeting Law.

The committee shall make recommendations to the Board of Managers on financial policies and assist in preparation for independent audit. All meetings of the committee shall be noticed and open to the public as required by the Open Meeting Law, except for meetings which are required to be closed or may be closed pursuant to the Open Meeting Law.

CALL FOR NOMINATIONS:

Manager Crafton nominated Tom Duevel to the Audit and Finance Committee. Manager Koch nominated Manager Koch to the Audit and Finance Committee. Manager Pedersen nominated Manager Crafton to the Audit and Finance Committee.
